## RESOLUTION

Approving the redevelopment contract and disposition supplement of the Redevelopment Authority of the City of Philadelphia for the redevelopment and urban renewal of a portion of the Model Cities Urban Renewal Area, designated as Parcel No. 57 also sometimes identified by respective house number and street address as 2927 Cecil B. Moore avenue; and authorizing the Redevelopment Authority to execute the redevelopment contract with Mary Coleman and to take such action as may be necessary to effectuate the redevelopment contract and disposition supplement.

WHEREAS, The Redevelopment Authority of the City of Philadelphia as hereinafter "Redevelopment Authority", has prepared and submitted an urban renewal plan and a redevelopment proposal for the redevelopment of the Model Cities Urban Renewal Area, as hereinafter "Model Cities", for which said plan and proposal were approved by Ordinance of the Council on December 15, 1969, as amended; and

WHEREAS, The Redevelopment Authority has prepared a redevelopment contract for a portion of Model Cities, designated as Parcel No. 57 also sometimes identified by respective house number and street address as 2927 Cecil B. Moore avenue (hereinafter "Parcel 57"). The area of Parcel 57 is bounded as follows:

### **Parcel No. 57 (2927 Cecil B. Moore avenue).**

ALL THAT CERTAIN lot or piece of ground situate in the Twenty-ninth Ward of the City of Philadelphia situate on the north side of Cecil B. Moore avenue (sixty feet wide) at the distance of seventy seven feet one inch west from the northwesterly side of Hollywood street (thirty feet wide); Containing in front or breadth of the said Cecil B. Moore avenue fifteen feet five inches and extending of that width or depth northward between parallel lines at right angles to the said Cecil B. Moore avenue the distance of seventy three feet to a point on the south side of a certain two feet

six inches wide alley that extends east into the said Hollywood street and west into Glenwood avenue (sixty five feet wide) and communicating with another certain two feet six inches wide alley that runs northeast to a point thence north and extending into the said Glenwood avenue.

The said redevelopment contract is in substantial conformity with the amended urban renewal plan and the amended redevelopment proposal approved by the Council.

WHEREAS, Mary Coleman desires to enter into the said redevelopment contract for Parcel 57; and

WHEREAS, The Redevelopment Authority has prepared a disposition supplement providing, *inter alia*, for development controls and regulations imposed upon Parcel 57.

RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA, That the redevelopment contract and disposition supplement submitted by the Redevelopment Authority of the City of Philadelphia (hereinafter "Redevelopment Authority") for the redevelopment of that portion of Model Cities, as hereinabove more particularly described, is hereby approved. City Council authorizes the Redevelopment Authority to proceed with minor changes in substantial conformity with the hereby approved redevelopment contract and disposition supplement. The Redevelopment Authority is authorized to execute the hereby approved redevelopment contract with Mary Coleman (hereinafter "Redeveloper"). The Redevelopment Authority and the Redeveloper are authorized to take such action in substantial conformity to the redevelopment contract as may be necessary to carry it out.

RESOLVED, The Redevelopment Authority and the Redeveloper are authorized to prepare or cause to be prepared for introduction into the Council such ordinances or resolutions as may be necessary for changes in zoning, streets, alleys, public ways, street patterns, location and relocation of public utilities, and related items which are required in order to facilitate and effectuate the redevelopment contract and disposition supplement hereby approved. Accordingly, the Council hereby declares that it will cooperate in helping to carry out the redevelopment contract and disposition supplement and requests the various officials, departments, boards and agencies of the City having administrative responsibilities in the premises likewise to cooperate to such end and to exercise their respective functions and powers in a manner consistent with the redevelopment contract and disposition supplement.
