RESOLUTION

Approving the redevelopment contract and disposition supplement of the Redevelopment Authority of the City of Philadelphia for the redevelopment and urban renewal of a portion of the Model Cities Urban Renewal Area, designated as Parcel No. 355 also sometimes identified by respective house number and street address as 1810 Ridge avenue and authorizing the Redevelopment Authority to execute the redevelopment contract with the Philadelphia Authority for Industrial Development and to take such action as may be necessary to effectuate the redevelopment contract and disposition supplement.

WHEREAS, The Redevelopment Authority of the City of Philadelphia as hereinafter "Redevelopment Authority", has prepared and submitted an urban renewal plan and a redevelopment proposal for the redevelopment of the Model Cities Urban Renewal Area, as hereinafter "Model Cities", for which said plan and proposal were approved by Ordinance of the Council on December 15, 1969, as amended; and

WHEREAS, The Redevelopment Authority has prepared a redevelopment contract for a portion of Model Cities, designated as Parcel No. 355 also sometimes identified by house number and street address as 1810 Ridge avenue (the "Property"). The area of said Property is bounded as follows:

Parcel No. 355 (1810 Ridge avenue).

ALL THAT CERTAIN lot or piece of ground situated in the Thirtieth Ward of the City of Philadelphia beginning at a corner formed by the intersection of the southwesterly side of Ridge avenue (sixty feet wide) with the southeasterly side of Ginnodo street (fifty feet wide); Thence extending southeastwardly along the said southwesterly side of Ridge avenue ninety two feet seven and three-quarters inches; Thence extending southwesterly along a line parallel with said Ginnodo street fifty four feet

five inches; Thence extending southeastwardly along a line parallel with Leland street (twenty feet wide) seventeen feet eleven and three-eighths inches; Thence extending southwestwardly along a line parallel with said Ginnodo street twenty two feet four and five-eighths inches; Thence extending northwestwardly along a line parallel with said Leland street seventeen feet eleven and three-eighths inches; Thence extending southwestwardly along a line parallel with said Ginnodo street ninety six feet one and three-eighths inches; Thence extending southeastwardly along a line parallel with said Leland street eleven feet eight and three-quarters inches; Thence extending southwestwardly along a line parallel with said Ginnodo street seventy eight feet one-eighth inch to the northeasterly side of said Leland street; Thence extending northwestwardly along the northeast side of said Leland street one hundred three feet eight and three-quarters inches to the southeastwardly side of said Ginnodo street; Thence extending northeastwardly along the southeast side of said Ginnodo street two hundred sixty one feet eight and seven-eighths inches to the first mentioned point and place of beginning.

The said redevelopment contract is in substantial conformity with the amended urban renewal plan and the amended redevelopment proposal approved by the Council.

WHEREAS, The Philadelphia Authority for Industrial Development desires to enter into the said redevelopment contract for the Property; and

WHEREAS, The Redevelopment Authority has prepared a disposition supplement providing inter alia for development controls and regulations imposed upon the Property.

RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA, That the redevelopment contract and disposition supplement submitted by the Redevelopment Authority of the City of Philadelphia as (hereinafter "Redevelopment Authority") for the redevelopment of that portion of Model Cities, as hereinabove more particularly described, is hereby approved. City Council authorizes the Redevelopment Authority to proceed with minor changes in substantial conformity with the hereby approved redevelopment contract and disposition supplement. The Redevelopment Authority is authorized to execute the hereby approved redevelopment contract with the Philadelphia Authority for Industrial Development as (hereinafter "Redeveloper"). The Redevelopment Authority and the Redeveloper are authorized to take such action in substantial conformity to the redevelopment contract as may be necessary to carry it out.

RESOLVED, The Redevelopment Authority and the Redeveloper are authorized to prepare or cause to be prepared for introduction into the Council such ordinances or resolutions as may be necessary for changes in zoning, streets, alleys, public ways, street patterns, location and relocation of public utilities, and related items which are required in order to facilitate and effectuate the redevelopment contract and disposition supplement hereby approved. Accordingly, the Council hereby declares that it will cooperate in helping to carry out the redevelopment contract and disposition supplement and requests the various officials, departments, boards and agencies of the City having administrative responsibilities in the premises likewise to cooperate to such end and to exercise their respective functions and powers in a manner consistent with the redevelopment contract and disposition supplement.
