WHEREAS, The fifth annual “Celebration of Hope,” which will offer educational conferences on cancer, as well as an “Evening Under the Stars” gala dinner and awards ceremony is fast approaching and that provides this City Council an ideal opportunity to honor this well deserving organization; now therefore
