RESOLUTION

Approving the redevelopment contract and disposition supplement of the Redevelopment Authority of the City of Philadelphia for the redevelopment and urban renewal of a portion of the Model Cities Urban Renewal Area, identified by house numbers and street addresses as 2303 & 2305 Lawrence street and 2308, 2310 & 2312 North Leithgow street and authorizing the Redevelopment Authority to execute the redevelopment contract with the School District of Philadelphia and to take such action as may be necessary to effectuate the redevelopment contract and disposition supplement.

WHEREAS, The Redevelopment Authority of the City of Philadelphia (hereinafter "Redevelopment Authority") has prepared and submitted an urban renewal plan and a redevelopment proposal for the redevelopment of the Model Cities Urban Renewal Area, (hereinafter "Model Cities"), which said plan and proposal were approved by Ordinance of the Council on December 15, 1969, as amended; and

WHEREAS, The Redevelopment Authority has prepared a redevelopment contract for a portion of the Model Cities Urban Renewal Area, identified by house numbers and street addresses as 2303 & 2305 Lawrence street and 2308, 2310 & 2312 North Leithgow street (the "Properties"). The area of the said Properties are bounded as follows:

2303 North Lawrence street.

ALL THAT CERTAIN lot or piece of ground located in the Nineteenth Ward of the City of Philadelphia with the buildings and improvements thereon erected situated on the easterly side of Lawrence street at the distance of seventy three feet northward from the northerly side of Dauphin street; Containing in front or breadth on Lawrence street twelve feet ten inches and extending of that width in length or depth eastward between parallel lines at right angles to

Lawrence street a distance of forty five feet to the centerline of a three feet wide alley.

2305 North Lawrence street.

ALL THAT CERTAIN lot or piece of ground located in the Nineteenth Ward of the City of Philadelphia with the buildings and improvements thereon erected situated on the easterly side of Lawrence street at a distance of eighty five feet ten inches northward from the northerly side of Dauphin street; Containing in front or breadth on Lawrence street twelve feet ten inches and extending of that width in length or depth eastward between parallel lines at right angles to Lawrence street a distance of forty five feet to the centerline of a three feet wide alley.

2308 North Leithgow street.

ALL THAT CERTAIN lot or piece of ground located in the Nineteenth Ward of the City of Philadelphia with the buildings and improvements thereon erected situated on the westerly side of Leithgow street at the distance of seventy three feet northward from the northerly side of Dauphin street; Containing in front or breadth on Leithgow street twelve feet ten inches and extending of that width in length or depth westward between parallel lines at right angles to Leithgow street a distance of forty five feet to the centerline of a three feet wide alley.

2310 North Leithgow street.

ALL THAT CERTAIN lot or piece of ground located in the Nineteenth Ward of the City of Philadelphia with the buildings and improvements thereon erected situated on the westerly side of Leithgow street a distance of eighty five feet ten inches northward from the northerly side of Dauphin street; Containing in front or breadth on Leithgow street twelve feet ten inches and extending of that width in length or depth westward between parallel lines at right angles to Leithgow street a distance of forty five feet to the centerline of a three feet wide alley.

2312 North Leithgow street.

ALL THAT CERTAIN lot or piece of ground located in the Nineteenth Ward of the City of Philadelphia with the buildings and improvements thereon erected situated on the westerly side of Leithgow street at the distance of ninety eight feet eight inches northward from the northerly side of Dauphin street; Containing in front or breadth on Leithgow street twelve feet ten inches and extending of that width in length or depth westward between parallel lines at right angles to Leithgow street a distance of forty five feet to the centerline of a three feet wide alley.

The said redevelopment contract is in substantial conformity with the amended urban renewal plan and the amended redevelopment proposal approved by the Council.

WHEREAS, The School District of Philadelphia desire to enter into the said redevelopment contract for the Properties; and

WHEREAS, The Redevelopment Authority has prepared a disposition supplement providing, *inter alia*, for development controls and regulations imposed upon the School District of Philadelphia.

RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA, That the redevelopment contract and disposition supplement submitted by the Redevelopment Authority of the City of Philadelphia (hereinafter "Redevelopment Authority") for the redevelopment of that portion of Model Cities, as hereinabove more particularly described, is hereby approved. City Council authorizes the Redevelopment Authority to proceed with minor changes in substantial conformity with the hereby approved redevelopment contract and disposition supplement. The Redevelopment Authority is authorized to execute the hereby approved redevelopment contract with the School District of Philadelphia (hereinafter "Redeveloper"). The Redevelopment Authority and the Redeveloper are authorized to take such action in substantial conformity to the redevelopment contract as may be necessary to carry it out.

RESOLVED, The Redevelopment Authority and the Redeveloper are authorized to prepare or cause to be prepared for introduction into the Council such ordinances or resolutions as may be necessary for changes in zoning, streets, alleys, public ways, street patterns, location and relocation of public utilities, and related items which are required in order to facilitate and effectuate the redevelopment contract and disposition supplement hereby approved. Accordingly, the Council hereby declares that it will cooperate in helping to carry out the redevelopment contract and disposition supplement and requests the various officials, departments, boards and agencies of the City having administrative responsibilities in the premises likewise to cooperate to such end and to exercise their respective functions and powers in a manner consistent with the redevelopment contract and disposition supplement.
